**In March of 2020, Congress began providing federal funding for school districts to address the emerging issues related to COVID-19. These funds are established under the Elementary and Secondary School Emergency Relief (ESSER) Fund.**

## **ESSER I**

### **CARES (Coronavirus Aid, Relief, and Economic Security) Act**

To address the impact COVID-19 has had on schools across the country.

## **ESSER II**

### **CRRSA (Coronavirus Response & Relief Supplemental Appropriations) Act**

To help safely reopen and sustain the safe operations of schools and address the impact of COVID-19 on students.

## **ESSER ARP**

### **ARP (American Rescue Plan) Act**

To safely reopen schools, sustain healthy operations and address the significant academic, social, emotional and mental health needs of students.



# WHAT SCHOOLS ARE ELIGIBLE FOR ESSER FUNDING

Eligible recipients include school districts and charter schools that received Title I, Part A Funding.

## Allocate vs. Award

School districts allocated under ESSER must still apply through their state to receive the allocation. Upon application approval, school districts are then awarded their allocated sum.

## What is the deadline to obligate ESSER funds?

ESSER I - September 30, 2022

ESSER II - September 30, 2023

ESSER ARP - September 30, 2024

## Obligate vs. Spend

School districts are not required to spend ESSER funding by the Deadline to Obligate Funds. Rather, school districts must have a plan in action with specific actionable expenditures in progress.

# ESSER QUICK FACTS

## ESSER I Funding

The Department of Education awarded emergency relief funds to address the impact COVID-19 continues to have on elementary and secondary schools across the nation.

### QUICK FACTS:

- + ESSER I Funding was established as part of the Education Stabilization Fund in the CARES Act.
- + The intent and purpose of this education funding is to prevent, prepare for and respond to the coronavirus.

## ESSER II Funding

An additional \$54.3 billion has been set aside for the Elementary and Secondary School Emergency Relief (ESSER II) Fund.

### QUICK FACTS:

- + According to the U.S. Department of Education, schools should plan to use all remaining ESSER I Funds prior to making use of their ESSER II Funds.
- + ESSER II places an emphasis on learning loss, preparing schools for reopening and testing, repairing and upgrading projects to improve air quality in school buildings.

## ARP ESSER

The ARP ESSER includes an additional \$122 billion to State Education Agencies (SEAs) and school districts to help safely reopen and sustain the safe operation of schools and address the impact of the coronavirus pandemic on U.S. students.

### QUICK FACTS:

- + 20% of funds are reserved to address learning loss through the implementation of evidence-based interventions; to ensure interventions respond to students' social, emotional and academic needs; and to address the disproportionate impact of COVID-19 on underrepresented student subgroups.
- + ARP ESSER places an emphasis on learning loss; evidence-based mental health/SEL; reopening schools to effectively maintain the health and safety of students, educators and other staff; and making publicly available plans for a safe return to in-school services on websites.

### Emergency Management Suite

## Suicide Awareness & Prevention

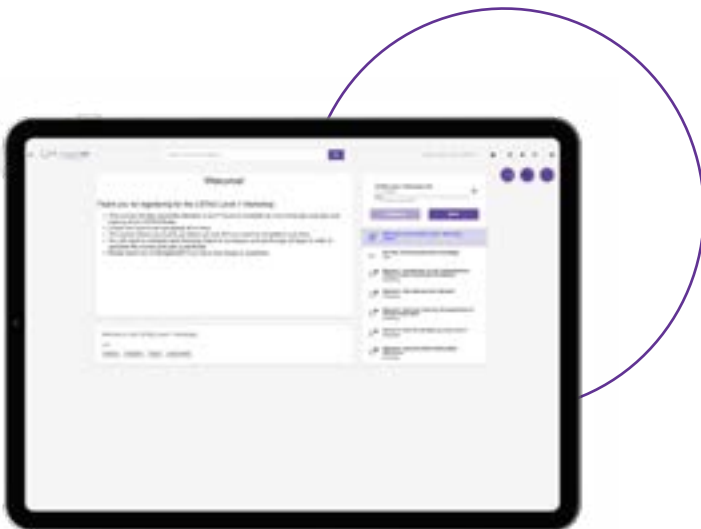

## CSTAG Level 1 Training

The National Threat Assessment Center (NTAC) Level 1 Training is behavioral threat assessment training that prepares participants to implement NTAC with high fidelity. NTAC Level 1 helps schools and districts identify students of concern, assess their risk for engaging in violence or other harmful activities and identify intervention strategies to manage that risk. Participants learn the NTAC process of identifying students of concern, screening the case, gathering information, analyzing information, assessing the student and managing the student.
